## to B.2.b.:

The organizers of the Dancesport section of the 2013 World Outgames held in Antwerp requested via e-mail for NASSPDA to authorize this event as the World Championships. NASSPDA turned this request over to IFSSDA.

## to B.3.a.:

# to B.3.b.:

On NASSPDA's website, under "About Us," current and former Board members are now listed in accordance to their status. It was agreed to distinctly separate those two listings.

No further update was available regarding the competition "Manatee Madness" in Florida that will allow participation of same-sex couples.

# to B.6.d.: Approved

The organizers of the Philadelphia Liberty Dance Challenge (PLDC) have agreed to host NASSPDA's 2012 US Championships, which are presumably held on March 31<sup>st</sup>, 2012.

No further update on this item was available at the time of this meeting.

## to B.7.:

USA Dance has been suspended by the NDCA. The suspension was due to USA Dance sponsoring a WDSF Adjudicator Congress and will not have any direct impact on NASSPDA. This issue somewhat relates to NASSPDA's and other organizations' concern about having NDCA registered officials work at their competitions, which are not NDCA sanctioned. However, the NDCA unanimously approved during their recent meeting that "specialty dance events," which are not covered by the rules of the NDCA, are exempt from that rule, since these competitions don't fall under their purview. This means that judges, scrutineers, and any other officials registered with NDCA are not prohibited from working at same-sex competitions
